

CRITERIA FOR STATE OFFICER CANDIDATES

- I. Cumulative grade point average of 2.5 minimum at college where enrolled. If no grade point average records have been accumulated, a letter from your instructors and/or advisor(s) stating that the candidate may potentially receive a 2.5 minimum grade point average will be acceptable.
- II. The offices of President, Vice President, and Administrative Finance Officer may be enrolled in any program at a technical college carrying a minimum of three credits for the entire term of office unless you are graduating.
- III. Potential state officer candidates must submit the following credentials:
